Fraud Alerts on Credit and Debit Cards

If you're traveling this summer, be sure to call us at 816-363-2223 to let us know where and when.

When your card is used in a place or manner different from your usual pattern, our Falcon Fraud department may call to make sure it is really you and not a fraudster. Tagging your card for travel cuts down on false fraud alerts that could block your card unnecessarily.

It will be helpful also to let us know if your phone numbers have changed so our fraud department can reach you when needed.

If you get such a call, and are worried about giving your card information to an unknown person, you can always hang up and call back at 866-334-1048, confident that you are giving your card number to our own fraud folks. Now might be a good time to add that number to your cell phone so you have it when needed.

They will ask you about each charge and unblock your card if all is well. If you don't call back they must decide whether or not to block your card, which could inconvenience you.
